This Evacuation Planning brochure was prepared by the Rancho Peñasquitos Fire Safe Council.

Officials will determine the areas to be evacuated and the evacuation routes to use depending on fire behavior.

Wildfires happen suddenly. These checklists can help you be prepared in case an approaching fire requires evacuation.

If you wait too long, you may experience severe traffic congestion and panic.

# **Get Ready to Go**


If you hear there is a wildfire approaching San Diego, it is time to get ready. It is time to PREPARE TO GO

• Load your car.

Grab-and-Go Bags
Daily essentials: money, medicine, glasses,
three-day supply of clothes
Pet crate, pet food
Valuables, pictures, computers, chargers

- Dress for evacuation and wear sturdy shoes.
- Close all windows and doors.
- Turn on all outside lights.
- Pull out and attach garden hoses.
- Close fireplace dampers.
- Shut off gas at the meter. Turn off pilot lights
- Move lawn furniture away from your house.
- Move barbeque grill (ensure propane tank is turned off), Lawnmower and other flammables away from your house.
- Review your Out-The-Door Checklist.
- Decide on your destination. Notify family members.
- Tune into 600 or 760 AM or any local TV station.
- Be alert for an emergency notification call.
- Apply your fire prevention gel, time permitting.
- Enact your evacuation assistance plan, if necessary

IF YOU SEE OR SMELL SMOKE... GO! DON'T WAIT!




To find your evacuation route, match the background color of your neighborhood to the similar color bold line, which indicates the major street you should use to leave Rancho Peñasquitos.

Remember, factors such as wind speed and direction, traffic problems, spot fires, first responder requirements, and so forth, may require alternate routes.

It is important that evacuees follow the directions of traffic control personnel

# **After the Fire has Passed**

- Check outside and in the attic for embers.
- Continue to be alert for spot fires around the house for a full day.
- Notify security patrols that you are safe.

There will likely be post-fire security patrols to prevent residents from entering or re-entering the area.

# If you Become Trapped

### In Your Home:

- Stay calm and keep your family together.
- Call 911 to advise officials.
- Fill sinks and tubs with cold water.
- Keep doors and windows closed.
- Remove curtains to avoid ignition by radiant heat.
- Move furniture away from windows.
- Stay inside, away from exterior walls and windows.
- Use wet towels to breathe through and to seal doors.
- Keep your fire extinguishers close by.

# In Your Car:

- Stay calm and park away from vegetation.
- Call 911 to advise officials.
- Close all windows and vents.
- Cover mouth with dry cloth to protect airway.
- Cover yourself with a wool blanket or jacket.
- Lie on vehicle floor and stay in the car until the fire passes.

### On Foot:

- Stay calm and find an area clear of vegetation, a ditch, or a depression on level ground.
- Call 911 to advise officials.
- Lie face down and cover up your body.
- Cover your mouth with a dry cloth to protect airway.

### IX New Business 7:56 PM

Roger: issues with grants and sponsorships since we don't have sponsor for banner district and no Fiesta (breaks even) and there are no plans for having a Fiesta in 2020.... Looking more like May of 2021 and so no money will be received. As of now no money towards Grants & Sponsorships. Checking has \$15427 Savings 10027 = 25454. Paypal 2111 Cash 100 = 27664... in our contributions receivable: nothing for banners, if we have receipts, we can get up to 2500 from Chris Cate, 17k from arts and culture commission, Grant from County of SD is given to us each year and we have to send receipts back justifying the 9k. We deposited that money in October of last year. Ceiling limits have been modified due to Covid: we asked for 8191 from arts and culture. Roger Wilson data report has already made determination that the 8191 would be reduced to 5000 for 2021. With no Fiesta expense, what can we budget for grants & sponsorships. (get exact numbers from Roger) – How much money will we have now for G&S, and after June of 2021 we may not as much? If no fireworks or fiesta or banner,6 community partners on repeat (6 \* \$250). Expanded use of community investment from the city, so what would be just fiesta. Kate: do we want to freeze G&S for now.

Jamal: Could we solicit companies ...SDCCU paying \$15k which is about \$400 per banner. Typically, corporate wants all or nothing.

We have to come up with a number for G&S. Brian: suggested maybe 10% of total income. Ralph: there is money being handed out for local governments, do we have as a community organization access to some of that money. Roger: asked Marc Schaefer said not to count on city funds, much of the relief money for non-profits are mainly for employees that have contracts and covid related expenses.

Alan: when he first joined, financials were so bad that G&S didn't happen for several years. We should have \$30k on hand for up front expenses for Fiesta, given the situation, he thinks it would be good idea to not issue G&S until financial situation clears up. Maybe start with 6 moths and keep extending if needed. Perhaps wait until we get reimbursements back. Could be that the level of grants and sponsorships will be what they were since schools are not in session.

Roger Motion: freeze grants for 6 months and review after 6 pending additional funds. Brian Seconds. Motion passes

Brian: questions: knowing we have 5000 in operating expenses, the only one that's questionable is replacing banners. We don't want them down, but we don't want them up tattered, only re did a few of them.

Jim: asked if banners are up? Maybe we can give them a discount on what they have. SDCCU already said no, they pulled back their community sponsorship.

Alan Requests 9 B, C, D to be postponed for 6 months. Esan second... No discussion. 12 in favor, Motion Passes. Small community outreaches for each district (curb connections). Small business groups are thinking of ways to gift the coupons. Create community atmosphere while promoting the Town Council. We are just discussing the idea to think about a sub-group to create.

Jamal: Sports seasons still going on, just postponed. If multi-sport athlete, logistical nightmare, no answer from CIF, also need to know what district will allow.... There may be extenuating circumstances, will also depend on coaches.
